Perfume and cosmetic products (PCP) is the type of product for which most countries have the most stringent requirements for its safe handling on the market and the main objective of such measures is primarily to protect the life and health of consumers.

In this article, we examined the issues of technical regulation of safe circulation of products on the EU and EAEU markets.

In the EU, PCP studies on the basic safety parameters are carried out in accordance with the International Organization for Standardization (ISO) requirements in accordance with the requirements of the EU directives by an independent organization – the Certification Body. In case of successful passing of tests, the manufacturing company receives a certificate that is entered into the European Register of Quality and makes it possible to circulate products on the EU market.

In this article, we have also wanted to draw attention to the similarity of technical regulation in the EU and the EAEU, which is a contributing factor for overcoming technical barriers to trade.
