

# Certification of Energy-consuming Products in the Context of New Challenges

We have reviewed the interim measures taken by the Eurasian Economic Commission in the face of an unfavorable epidemiological situation related to coronavirus infection (COVID-19). The measures are aimed at preventing a shortage of these products in the EAEU market. It should be applied when conducting conformity assessment in the form of certification of mass-produced energy-consuming products for compliance with the requirements of the EAEU technical regulations.

We have shown that temporary measures that supplement the standard schemes of products' conformity assessment would be valid for one year, from January 10, 2021 to January 10, 2022. We have considered how, within the framework of the measures taken, accredited product certification bodies should identify and select samples (tests) of products from the applicant, analyze the state of production, as well as carry out inspection control of certified products. We have talked about the mandatory requirements that the EAEU member states must fulfill so that the adopted restrictions exclude the possibility of low-quality, unsafe and falsified energy-consuming products entering the EAEU consumer market.
