organization, accreditation, certification, quality management system, internal audit, integration, improvement We have proposed a dependence for calculating the integration levels, determined by the ratio of the number of general and additional individual requirements, taking into account the complexity of documentary formalization and the labor intensity of the work for the latter.

It is stated that the managed integration of regulatory document requirements reduces the number of internal documents and allows for monitoring the fulfillment of requirements simultaneously for different types of activities and local management systems of accredited and certified organizations.

We have recommended to use quality management system tools to improve the internal audit system — assessing the risks and opportunities of each process at different management levels and each function of the PDCA cycle.
