Import substitution in our country is implemented with the active participation of the state, including through the mechanism of state defense order, it's known. This process effectiveness largely depends on the quality of interaction between participants in the state defense order system. In this regard, we formulated recommendations for improving this interaction.

Set of our developed measures will allow us to avoid overpricing military and military equipment and to more effectively comply with the interests of the state, we believe. Proposed costing methodology will provide a unified legal framework for determining the cost of production supplied by second suppliers within the framework of the state defense order.

The use by suppliers and customers of a unified approach to pricing will limit the multiplicative increase in the cost of the electronic component base caused by the repeated purchase of products by suppliers.
