Also we have studied the legislation of other countries — members of the Eurasian Economic Union (EAEU) in the same field. In the course of the study we have identified the specific features of the EAEU member states laws on the organization of state control and supervision over compliance with mandatory product requirements.

The study showed the possibility of forming common approaches to the exercise of powers to control and supervise in the field of handling mineral fertilizers in compliance with the mandatory requirements established by the EAEU TR 039/2016.

Based on the results obtained, the principles of the state authorized bodies control and supervisory functions over the observance of legislation on the EAEU market mineral fertilizers circulation can be determined common to all member countries of the Union. In conclusion, general principles of control and supervisory functions for all EAEU member countries can be developed.
